



HOMEOWNER AGREEMENT

_____ I understand that Rebuilding Together Sandoval County (RTSC), its employees, agents, donors, volunteers, and participating trade workers are part of a volunteer driven initiative and that guarantees cannot be made as to the specific work that will be done.

_____ I understand that the general plan for repairs to my home will be explained to me and I give RTSC, and its employees, agents, donors, volunteers, and participating trade workers full authority to determine the extent of the repairs to be performed on my home, even if they should fail to notify me of any change to the original plan.

_____ I understand that the repairs will be performed free of charge by volunteers and/or participating trade workers, and that RTSC, its volunteers, employees, agents and participating trade workers disclaim all warranties, expressed or implied concerning the repair(s).

_____ In consideration of the repair(s), I further hold RTSC, its officers, directors, employees, agents, donors, volunteers, participating trade workers, and other affiliates, collectively and individually, harmless from any and all claims and liabilities arising at any time as a result of the repairs, including, without limitation, any rights or causes of action resulting from personal injury or death, or damage to my property, directly, or indirectly arising from any improperly performed repair(s) or defects in material or workmanship.

_____ No inducements or promises have been made to me to secure my signature on this release other than the intention of RTSC to perform the repairs and improvements.

_____ It may be necessary to have a dumpster and portable toilet parked on my property for the project. I give my permission to place these where necessary.

_____ I understand that the repairs and improvements will be made as scheduled by RTSC as funding and volunteers are available.

_____ I grant RTSC permission to take or have taken, still and moving photographs and films including television filming of my home. I consent and authorize RTSC, its advertising agencies, news media or any other persons interested in Rebuilding Together, and its works, to use and reproduce the photographs, films, and pictures and to circulate and publicize the same by all means including, without limiting the generality of the foregoing, newspapers, television media, brochures, pamphlets, instructional materials, books and clinical material.

_____ I grant RTSC permission to disclose relevant information regarding the assistance I have received to donors and/or in marketing materials, newsletters, and social media. This may include information regarding the nature of repairs and my general family situation; however, my personal identity and/or address will not be disclosed without my expressed permission.
